71st Annual Congregational Meeting November 13, 2022 Unapproved Minutes

Meeting called to order at 11:11 by Church Council President Kathy Fair

56 Voting Members in attendance, seven being on ZOOM

Confirmation of Quorum- Gail Kruse and Carol Hansen

Pastor Ed Foster opened with prayer.

A motion to approve Congregational Meeting minutes of November 14, 2021 was made by Gail Kruse. Wendy Blomberg seconded the motion and all approved.

Pastor Foster reported that Kent is indeed continuing to fulfill both its mission as a congregation and to live out it's mission statement. Kent has proclaimed the Gospel in both our words and in our actions. We hear God's word. We continue to respond in love. And we do share Jesus with all. The first 2 years of his ministry at Kent have been challenging times for the Church in general. The pandemic and social conditions in the world have created challenges that the whole Church has struggled to meet. Our congregation has faced those challenges with faith and courage, continuing to care for one another in new and innovative ways, and continuing to reach out with the compassion and love that our Lord has entrusted to us. Al Mohling presented the 2023 Budget. Budget changes were reviewed. Al asked for questions from the floor, having none, Al Mohling made a motion to accept the Council approved proposed budget as presented. A voice vote to accept the proposed 2023 budget was made all approved.

BUDDY PACKS

(subcommittee of Evangelism)

Kent Memorial has had a summer Buddy Pack program since 2014. We had 13 families that first year receiving food that was mostly donated from the congregation. That same year Kent's good friend, Vaclav "Vinny" Stepanik (owner, Vinny's Café, Laurie, MO) started his Buddy Pack Golf Tournament and has been our biggest supporter ever since.

On all long weekends and school holidays we send home extra food to help support the boys and girls. In the summer we send home letters to all children at Hurricane Deck to see if their families are interested in our summer Buddy Pack Program.

We provide enough food for at least 8 main dishes, breakfasts, and snacks. If there are multiple children in the family, there is enough food to feed all the children no matter if they are in school yet or in middle or high school. For example, instead of 3 individual cans of spaghetti, we send a package of spaghetti noodles and a jar of sauce. This year we added a gift certificate to Sav-a-Lot to purchase fresh vegetables, fruit, or milk. This year we had 13 families that were very faithful about picking up their food or making other arrangements to get their food.

We are blessed to have great community support for this program and to have such a friend in Vinny.

Every committee member has the responsibility of overseeing a particular task, such as the lawn mowing, weed control and leaf removal, snow removal, caring for the outdoor worship area, garage, columbarium and pageant area along with the maintenance of the parsonage and church building. - Creative Vision Plumbing replaced the urinal in the unisex fellowship restroom.

- Co-Mo Electric contractors trimmed and removed many trees along the back of the church building to meet new distant clearance guidelines.
- Roof Masters has cleaned out the cutters on the back side of the building, repaired metal flashing and inspected the shingles for damage.

SOCIAL MINISTRY COMMITTEE

To all of Kent Memorial's congregation, family and friends, Thanks to your Faith and Love of God this committee was able to assist many families and outreach ministries with financial and spiritual support.

The goals of Social Ministry are in keeping with the guidance of congregation, church council and Constitution of Kent Lutheran.

- Responding to needs of the poor and distressed in our community and society
- As Christians support outreach organizations as volunteers, prayers and financially
- Encourage members of Kent to support and comfort those that are ill and their caregivers
- Committee will be good stewards of financial resources entrusted to our care
- Inform congregation of service opportunities in which they might engage as Christians
- Listen and react to the changing needs of our family and community

Funds available to assist those in need represent the generosity of our congregation. Designated envelope offerings, special gifts, and fund raisers enable the committee to answer needs calls during the year. Committee members have the responsibility to serve as good stewards when responding to individuals and outreach ministries. Therefore, the committee works in cooperation with other area Churches, Westside Ministerial Alliance and outreach facilities to combine available funding for the best outcome. During 2022 a total of families 60 were assisted with rent, utilities, gasoline, medications, car repairs and other needs. In addition to financial assistance provided to families, they are offered spiritual guidance, prayers and encouragement to attend church services of their choosing.

Below is a brief financial statement of expenditures and offerings for 2022, balance January 1, 2022 was \$5,302.65, with an ending balance December 31, 2022 of \$5,794.95. A monthly report is shared with the council and in the monthly newsletter. Beginning balance January 1, 2022 was

The only fundraiser held to benefit Social Ministries is the card bingo night. The event was a success, thanks to all who participated. Total funds raised were \$3,256.

Kent Memorial supports several outreach ministries through the budget in benevolence. Agencies included in the approved 2022 budget are, Community for Christ, Share the Harvest, Westside Senior Center, Lake Area Helping Hands, CADV, and Once We were Refugees.

Additional activities supported by the congregation in 2022:

- BLUE BOX The congregation is encouraged to bring pantry and household items to the church and place them in the Blue Boxes located in the narthex and fellowship hall. An approximate total of 2550 items were donated. These items are then donated to Community for Christ food pantry, which then distributes them, at no charge, to those in need. In 2022 a total of 517 families, increase of 50% over previous year, have been assisted through the CFC food pantry. Needs vary monthly and are published in the monthly newsletter and bulletin. Thanks to Sharon and Bob Ballard, for the time and effort spent.
- **FESTIVAL of Sharing** This is an ecumenical effort through which there is a state-wide gathering of food and goods. Distribution is broken down in area segments. This year Kent donated \$445.
- Bingo Night See note above.
- The Loving Gifts Tree In 2022 the congregation again generously provided gifts for 50 children/mothers through CADV. These people are starting their lives over without anything from their previous homes. These gifts help provide some normalcy as they start a new abuse free life.
- Salvation Army Bell Ringing A gift of \$700 was made to Salvation Army in 2022. 80% of funds collected in 3 county area are redistributed, thru outreach centers, to this local area.

The Committee is thankful and appreciative for all the support offered by congregation and friends for outpouring of heartfelt caring for your community. The Committee thanks Pastor Ed for his support, prayers and leadership. Also, the committee gives a special thanks to Kathy Fair for her commitment during 2022.

2022 was a year of joy and opportunity for Kent Memorial as we faithfully worshipped our Lord and strove to "Share Jesus With All." Though a majority of members are back worshipping in the sanctuary, we continue to offer online worship for those unable to attend in person, and weekly share our services via YouTube for others to discover Kent Memorial. On average we had 16 worshippers on Zoom each Sunday and approximately 50 viewing the service on YouTube. Special thanks to Pastor Ed for the time he spends making and uploading the full service and condensed service videos.

Lent was a wonderful journey in 2022. An average of 31 worshippers attended each week, then gathered in the Fellowship Hall for a meal and fellowship time.

Palm Sunday began Holy Week and the journey to the cross, Maundy Thursday reminded us of Jesus' arrest in the garden, Good Friday was a moving service focusing on Christ's crucifixion; then with a joyous shout we proclaimed our Savior risen on Easter Sunday morning! Our 54th Annual Easter Pageant, "He Is Risen!", returned this year and was a rousing success. The crowd continues to grow for the performance.

Midweek Advent Services had an average attendance of 28 in the sanctuary and online, where we put Judas Iscariot on trial in "The People vs. Judas Iscariot." We worshipped together, then

adjourned to the fellowship hall for a meal and time together. Our appreciation is extended to everyone who participated.

The Christmas Eve Candlelight Communion Service was a beautiful experience. We welcomed 134 worshippers both in our sanctuary and online. Our thanks to Margo Strothmann, Joyce Wanamaker, the singers, the handbell players, and instrumentalists for sharing their gifts that evening.

We finished 2022 with our traditional Lessons and Carols style Hymn Sing. Worshippers had fun singing as many favorite hymns as possible that morning.
